The question was brought by Joan Lyon and the motion passed intact unanimously.

#### II. New Business

### A. Treasurer's Report

Grace itemized all are credits and debits. Our total in the account prior to the deductions and including monies from the auction was \$1919.51. Our deductions totalled \$760.99; leaving an overall balence of \$1158.52.
