Delta Kappa Gamma Gamma Alpha Chapter Business Meeting September 20, 1989

- I. The meeting was called to order at 7:15 p.m. by President Fran Saenz.

Sandy made a motion to increase the Gamma Alpha dues to \$50.00, with a second by Marie. The motion carried.

New members paid their dues of \$27.80 last May and will pay the difference of \$22.20.

V. Unfinished Business

Sherry informed us that the Professional Affairs Committee needs a chairman. The Music Committee needs members, June Chartrand is chairman.

Harriet made a motion that \$250.00 retroactive from last year and \$250.00 from this year's budget be used for scholarhips. Second by Georgie. A five person committee will decide on recipients. Get forms from Clare.

VI. Committee Reports

A. Yearbook: Sandy and Esther said the yearbook will be ready by the October meeting. It will contain directions for both phone fan-out and dispersal of written communications.

- B. Newsletter: Shirley asked that information sent to her is typed, and that she is kept informed of events that should be in the newsletter. She also suggested sending postcards as reminders of some meetings to cut down on postage costs. Barb and Esther volunteered to be contact persons so written communications can be sent through school mail, requiring no postage.
- C. Fashion Show: Barb and Nancy. The Fashion Show will be held at the new Marriott at 6 Mile and I-275 on March 14, 1990. Casual Corner, Caren Charles, T. Deane, and Crowley's will supply the fashions. A sign-up sheet for committees was circulated. Chairmen of those committees will meet in October to formulate plans. Tickets need to be ready for sale by January. There was discussion on whether the show should be video-taped, no conclusion.

Alice suggested that Grace's afghan be raffled at the Fashion Show, in addition to a 50-50 raffle.

Georgie made a motion to continue to use the proceeds from the Fashion Show this year for the Scholarship Fund. Second by Clare. The motion carried.

- D. Personal Growth and Services: Pat asked members to bring books suitable for children of all ages to be wrapped at the November 15 meeting. They will be distributed to the appropriate people to be given to the needy in our area. Harriet will bring bookplates. Dinner will be at the Hillside. Georgie will send us more information on choices.
- E. Nancy reported that the speaker at the October 25 meeting will be Mary Dean Barringer, member of the National Board for Professional Teaching Standards. The meeting will be held at the Timothy Dyer Center, with the jewelry sale at 6:00, meeting at 7:00. Sherry asked that members make an effort to contact persons for this meeting, sponsored by the Research Committee.
- F. Legislation: Pat gave us information on Proposals A and B which will be on the ballot on November 7. They are an effort to increase funds for education, and will raise the sales tax by $\frac{1}{2} \not e$ and $2 \not e$ respectively. Out-of-formula schools could be hurt by B.
- G. Membership: Carol reminded us to be thinking of new members for the chapter. New member nominations will be presented at the January 10 meeting. Our numbers have grown significantly since Gamma Alpha was established. We are now a group of 54.
- H. Metro Council: Fran said there are 8-10 chapters in the area. Metro Council wants to support one charity. See Fran or Georgie with ideas. Georgie suggested First Step.
- I. Empathy: Marie sent roses to Candy, Doreen, Joan, and Clare.
- J. Birthday Luncheon: Alice said it would be held at Mountain Jack's on May 23. More information will be coming.

- History: Debbie will bring an album of recent pictures and articles to a future meeting.
- L. Nominations: Debbie's committee needs input. She will bring a form to the October meeting on which members can indicate who they would like to see in office or which office they would consider taking. They will be contacted by phone. The committee will meet in November and the slate will be ready in January.
